

# Shape the future of cervical cancer screening: Identify HPV 31



#### Adapt to the evolving landscape of cervical cancer screening

The evolving cervical cancer screening and management guidelines and changes in HPV genotype prevalence are impacting clinical management and calling for a shift towards **next-generation HPV** screening with extended genotyping.<sup>5,6,10,11</sup>




Consensus guidelines favor a **personalized risk-based management** of cervical cancer screening results with **HPV testing as the foundation for risk-estimation.**<sup>5</sup>



#### HPV 31 identification matters. Extended genotyping is critical.

Following the American Society for Colposcopy and Cervical Pathology (ASCCP) principle of **"similar management for similar risk"**, women with an immediate risk for CIN3+ disease above 4% should be referred to colposcopy.<sup>5</sup>

In the BD Onclarity<sup>M</sup> HPV Assay FDA trial, women 25 years and older with HPV 31 and normal cytology had an immediate risk for CIN3+ similar to HPV 16 that exceeds the colposcopy referral threshold of 4% recommended by ASCCP management guidelines.<sup>5,7</sup>




#### Risk of CIN3+ by HPV type in women $\ge$ 25 years with normal cytology
